## Conditions

---

### General

The tournament will be played in full accordance with the Laws of Badminton, the BWF Competition Regulations and Badminton Europe's Elite Circuit Instructions as effective from January 1st, 2018. In case of any dispute, the Referee's decision shall be final. Badminton Europe and/or the organization are not liable for any claims, actions, damages, costs or expenses of any nature whatsoever, arising out of or in any way related, directly or indirectly, to the tournament (see Elite Circuit Regulation 3.6). Badminton Nederland can cancel the tournament in case of force majeure until 15 days before the start of the tournament without being liable for any expenses incurred by third persons (see Elite Circuit Regulation 3.4).

### Entries

a) Only entries that are entered by Member Associations through the online system at <https://bwf.tournamentsoftware.com/sport/tournament.aspx?id=6DDE4362-918B-46BA-880D-BD7B9711DE46> will be accepted. If needed, Member Associations can obtain the required username and password from BWF's Senior Events Officer: s.ramachandran@bwfbadminton.org.

b) Entry closing date is Tuesday March 13th, 2018 23:59h BWF headquarters time (+08:00GMT).

c) After the closing date, the BWF Online Entry System will send a notification confirming receipt of final entries to all participating Member Associations. Receipt of this notification is the conclusive evidence of receipt of entries before the deadline.

d) Please note that questions about accommodation or transport should be directed to the accommodation manager ([accommodatiemanager@velo-badminton.nl](mailto:accommodatiemanager@velo-badminton.nl)).

### VISA procedure

Competitors and officials who need Visa for the Netherlands, should send the Visa application form not later than March 1<sup>st</sup>, 2018, to the tournament secretary (phone +31 30 2020177, e-mail [dutchinternational@badminton.nl](mailto:dutchinternational@badminton.nl)). We will not accept entries needing visa without such an application. The Visa application form as published on the BWF webpage dedicated to the Victor Dutch International 2018 and all requested

information (full names, dates of birth and passport numbers of all players and officials) should be provided.

### **Tournament events and qualifying rounds**

- a) The committee will restrict entries into all tournament events, and, if necessary, into any qualifying event as well, according to BWF regulations.
- b) The draw sizes of the main events will be as follows: 32 MS, 32 WS, 24 MD, 24 WD and 24 XD. If the number of competitors in any event would fall below the minimum levels specified in Badminton Europe's Elite Circuit Instructions Article 3.3, such an event will be cancelled. The M&Q Report will be published on March 16<sup>th</sup>, 2018, and will be based on the World Ranking dated March 15<sup>th</sup>, 2018.
- c) Member Associations will be acknowledged as to which of their entries have been accepted into the Main Draw, which are required to qualify, and which are on the lists of reserves.
- d) Seeding will be done by Badminton Europe, based on the World Ranking dated March 22<sup>nd</sup>, 2018.
- e) The draw will be made by Badminton Europe, on Tuesday March 27<sup>th</sup>, 2018.
- f) The final version of the order of play will be published at least 15 days before the start of the tournament.
- g) Players should not plan their departure less than two hours before their last match is planned to conclude (see Article 9.5 of the Elite Circuit Instructions).
- h) Please ensure that the Secretary of the Committee of Management is informed immediately when a player has to withdraw, together with the reason.

#### ***Attention:***

- a) If a player who is accepted into the tournament withdraws from one or more events after Monday March 26<sup>th</sup>, 2018, the Member Association entering the player shall make a payment of €150 to the BWF.
- b) Any player not showing up at the tournament, without having been withdrawn in advance, renders the Member Association concerned liable to an additional amount of US\$ 500,00 for the inconvenience caused by the "no show" (as defined in BWF General Competition Regulations).

### **Match conditions**

- a) Competitors must be prepared to play at the times quoted in the Order of Play for the events for which they have entered. No exception shall be made to this rule.
- b) Matches will be played according to BWF laws.
- c) The period for knocking-up before any match shall not exceed 3 minutes.

- d) The tournament's official shuttlecock is the VICTOR Champion Gold.
- e) Testing for the use of drugs can be conducted throughout the tournament.
- f) During the entire tournament, at most two courts will be equipped to enable betting. For these courts, a specific order of play might be announced. Betting by players, coaches and team officials on matches of the tournament is strictly forbidden.
- g) During the event, stringing service will be present.
- h) There will be two managers' meetings: on Wednesday April 11<sup>th</sup>, 2018 and Thursday April 12<sup>th</sup>, 2018, both at 19.00 hrs. in a signposted room at the tournament venue.
- i) Information for training courts is available on our website.
- j) The matches will be played on Yonex courts.

### **Clothing and advertising**

Clothing and advertising is allowed as in the BWF competition regulations 19 to 23. According to the Elite Circuit Regulations 18.2 and 18.3.

- the player's name on the back of the shirt is mandatory at all time during play in the semifinals and finals.
- it is mandatory for the semifinals and finals that partners in doubles wear the same colour.

### **Transport and accommodation information**

a) There will be regular transport between Amsterdam Airport Schiphol, Kijkduinpark, Best Western Plus Grand Winston and the tournament venue. This service is free of charge from Wednesday April 11<sup>th</sup>, 2018 to Sunday April 15<sup>th</sup>, 2018. Transport to other locations will not be provided by the organizers. b) The players' accommodation will be in:

- The bungalows of the holiday-park "Kijkduinpark", Machiel Vrijenhoeklaan 450, Den Haag.

This is about 10 minutes by car from the tournament venue. The prices vary according to the leaflet that is enclosed with this entry form. The prices for accommodation include sheets and towels, tourist-tax and cleaning. ## **Accommodations**

VELO Badminton can offer you an attractive arrangement to stay at the beautiful "Kijkduinpark". This is a park with chalets and villas directly on the shore and at a 10 minutes' drive from the tournament venue. "Kijkduinpark" offers a lot of facilities to comfort your stay during the tournament: free swimming pool, supermarket, restaurants, bar, snack-bar, tennis courts, golf court, and of course the Dutch coast. We offer you a choice between three types of chalet:

- Chalet A**
- Chalet for a maximum of 4 persons.
  - One bedroom with a double bed (two mattresses) and one bedroom with two single beds.
  - Bathroom with shower, washbasin and toilet.
  - Kitchen with microwave and gas cooker.
  - Living with TV.

- Villa B**
- Luxury villa for a maximum of 7 persons.
  - Three bedrooms, one with three single beds, one with two single beds and one bedroom with a double bed.
  - Bathroom with shower and bath/whirlpool.
  - Second bathroom with shower, second toilet and sauna.
  - Fully equipped kitchen with microwave and dishwasher.
  - Living with TV and fireplace.

The chalets and villas can only be rented for at least 4 nights (arrival on Wednesday April 11<sup>th</sup>, 2018, departure on Sunday April 15<sup>th</sup>, 2018) for a fixed price, see the reservation form. Costs include sheets, towels, tax and cleaning. Transfers by minibus from Amsterdam Airport Schiphol to "Kijkduinpark" v.v., and transfers from "Kijkduinpark" to the tournament venue (approximately every half hour) are also included, in the period April 11<sup>th</sup> - April 15<sup>th</sup>, 2018. The organization committee is willing to look at the possibility if chalets and villas can be shared with participants from other groups if desired, but cannot give any guarantees that such attempts will be successful.

Costs of chalets and bungalows should be paid in advance with the entry fees of the tournament. Please indicate the type(s) of chalet/villa and the number(s) of persons in a chalet/villa. If cancellations of chalets and villas at the Kijkduinpark are made after March 21<sup>st</sup>, 2018 the full amount due will be charged, refund is impossible.
